# Declaration of personal data protection (GDPR)

---

YOU vastgoed and YOU Realestate declare that in accordance with the current laws and regulations concerning the processing and processing of personal data, including the Algemene Verordening Gegevensbescherming (AVG) as applicable from 25 May 2018, and the GDPR (General Data Protection Regulation: see [www.gdpr-info.eu](http://www.gdpr-info.eu)) the following:

- **Data that is being saved**

1. YOU vastgoed and YOU Realestate only store personal data that the notary deems necessary for the purchase or sale of the property to be acquired or sold, and
2. In addition, in some cases e-mail addresses and telephone numbers of interested parties in real estate objects, and any wishes relating thereto or real estate search specifications are recorded. These personal data are not used for purposes other than those for which they were intended by the relevant persons themselves, and in principle are not passed on to third parties.

- **Sharing personal data with third parties**

YOU Vastgoed and YOU Realestate share your personal data with various third parties if this is necessary for the execution of the agreement and to comply with any legal obligation. Insofar as companies process data in our assignment, we conclude a processor agreement to ensure the same level of security and confidentiality of your data. YOU Vastgoed and YOU Realestate remain responsible for these processing operations. In the case of the Drift service YOU Vastgoed and YOU Realestate refer to the website [www.drift.com](http://www.drift.com).

- **View, modify or delete data**

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by YOU Vastgoed and YOU Realestate and you have the right to data portability. This means that you can submit a request to us to send the personal information we have in your computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to [info@youvastgoed.nl](mailto:info@youvastgoed.nl). To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We respond as quickly as possible, but within four weeks, at your request. YOU Vastgoed and YOU Realestate would also like to point out that you have the opportunity to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.

- **How we protect personal data**

YOU Vastgoed and YOU Realestate take the protection of your data seriously and take appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification. There is no link between the saved data and the YOU realestate and YOU realestate websites. If you feel that your data is not properly secured or there are indications of abuse, please contact us via [info@youvastgoed.nl](mailto:info@youvastgoed.nl).

- **Cookies, or similar techniques, that we use**

YOU Vastgoed and YOU Realestate uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. YOU Vastgoed and YOU Realestate uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work well and to optimize it. You can opt out of cookies by setting your internet browser in such a way that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

- **The storage of your personal data**

YOU Vastgoed and YOU Realestate keep the personal data in a secure (Cloud) environment. Measures have been taken to prevent abuse and improper access. There is no direct link with the websites of YOU real estate and YOU Realestate.

- **Automated decision-making**

YOU Vastgoed and YOU Realestate do not make decisions about matters that can have (significant) consequences for people based on automated processing. These are decisions taken by computer programs or systems, without involving a human being.

- **Special and / or sensitive personal data that we process**

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. However, we can not check if a visitor is older than 16. We encourage parents to be involved in the online activities of their children, in order to prevent data about children being collected without parental consent.
